List of 10 Mergers and Acquisitions Formulas

Mergers and Acquisitions ↗

1) Accretion Amount ↗

fx AA = $\left((PB) \cdot \left(\frac{YTM}{APPY} \right) \right) - CI$

[Open Calculator ↗](#)

ex $394500 = \left((2000) \cdot \left(\frac{1200}{6} \right) \right) - 5500$

2) Control Premium ↗

fx CLP = $\frac{TPR - MP}{EP}$

ex $1.002857 = \frac{5005 - 1495}{3500}$

3) Gain of Acquirer ↗

fx GAQ = S - (PT - VT)

ex $19990 = 25000 - (10000 - 4990)$



4) Goodwill 

$$fx \quad G = CP + FVNI + FVEI - FVNR$$

Open Calculator 

$$ex \quad 2500 = 1300 + 1700 + 2300 - 2800$$

5) Merger Arbitrage Spread 

$$fx \quad MARS = RP + RFR$$

Open Calculator 

$$ex \quad 254.08 = 254 + 0.08$$

6) Post Merger EPS 

$$fx \quad PME = \frac{TEAP}{TNSA}$$

Open Calculator 

$$ex \quad 5.2 = \frac{520}{100}$$

7) Post Merger PE 

$$fx \quad PMP = WAEA + WAET$$

Open Calculator 

$$ex \quad 4.2 = 1.30 + 2.90$$

8) Post Merger Share Price of Acquirer 

$$fx \quad PMSPA = APR \cdot APE$$

Open Calculator 

$$ex \quad 1.995 = 1.5 \cdot 1.33$$



9) Post Merger Value of Merged Company 

fx
$$\text{PMV} = \text{PVA} + \text{VT} + \text{S} - \text{C}$$

Open Calculator 

ex
$$40990 = 20000 + 4990 + 25000 - 9000$$

10) Takeover Premium 

fx
$$\text{TPM} = \text{PT} - \text{VT}$$

Open Calculator 

ex
$$5010 = 10000 - 4990$$
